Articles of Incorporation

The undersigned, acting as incorporator of a corporation under Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

1. Name & Address. The name of this corporation is, R.D.F. ENTERPRISES, INC.
2. Duration. The period of its duration is perpetual.
3. Purpose. The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
4. Capital Stock. The corporation is authorized to issue 500 shares, all of one class, at \$1.00 per value.
5. Initial registered office and agent. The name and address of the initial registered agent and office of the corporation is as follows;
