ARTICLES OF INCORPORATION OF INCREDIBLE PRODUCTIONS, INC.

SS JULI 7 PH 2: 14

We, the undersigned, being of legal age, do hereby hadgasted for the purpose of becoming a corporation under the laws of the builty of Florida authorizing the formation of corporations.

ARTICLE I

The name of the corporation shall be INCREDIBLE PRODUCTIONS, INC.

ARTICLE II

The general nature of the business and the object and purposes proposed to be transacted and carried on are to be engaged in are any and all activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE III
