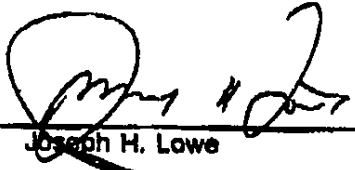
Pursuant to Section 621.05, Florida Statutes, these articles of Incorporation provide that:

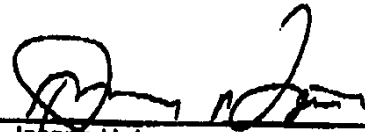
