ARTICLE I - NAME

The name of this corporation is Rusher Consulting, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE


ARTICLE VIII - INDEMNIFICATION

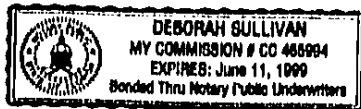
