ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Floriday General Corporation Act, adopt the following Articles of Incorporation for such corporation:

- 1. The name of the corporation is Jack Keith Electric and Sons law.
- 2. The period of its duration is perpetual.
- 3. The purpose is to engage in any activities or business permitted under the laws of the United States and the State of Florida.
- 4. The corporation shall have authority to issue 1000 shares of common stock having a par value of \$1.00 per share.
- 5. The address of its initial registered office is 509 Lagoon Oaks Circle, Panama City Beach, Florida, 32408, and the name of its initial registered agent at said office is Jack Keith.
- 6. The number of directors may be from time to time fixed by the shareholders. The number of directors constituting its initial Board of Directors is two, whose name and address is as follows:

- The power to adopt, alter, amend or repeal the By-Laws shall be vested in 8. the Board of Directors and the Shareholders, and said power shall be exercised by a unanimous vote of the Directors and Shareholders.
- 9. The Shareholders shall have the power to adopt, amend, after, change or repeal the Articles of Incorporation when proposed and approved at a Stockholder's meeting by a unanimous vote of all common stock issued and outstanding.
- The unanimous consent of the Stockholders of the corporation shall be 10. required for any Shareholder action.
- 11. The unanimous consent of the Board of Directors of the corporation shall be required for any action of the Board of Directors.
- The holders of the outstanding capital stock shall be entitled to receive, 12. when and as declared by the Board of Directors, dividends payable either in cash, in property or in shares of capital stock of the corporation.
