ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

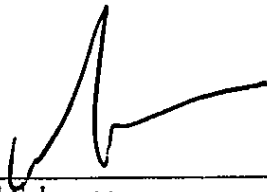
ARTICLE VIII
