ARTICLE I--NAME

The name of this corporation is A & C CUSTOM CARPENTRY, INC.

ARTICLE II--DURATION

This corporation shall exist perpotually.

The power to adopt, alter amend or repeal by-laws of this corporation shall be vested in the member.


ARTICLE XI--INDEMNIFICATION


