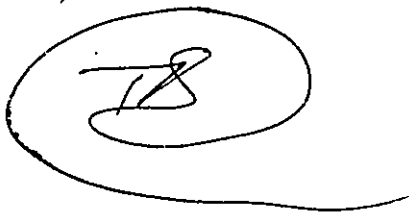

CERTIFICATE OF INCORPORATION

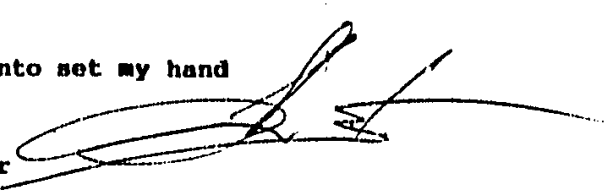

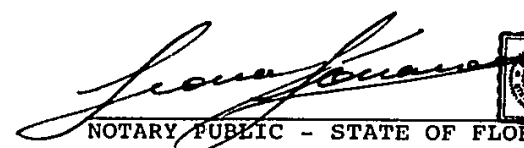

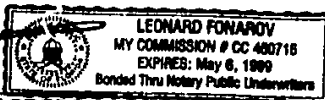
