**ARTICLE I - NAME**

The name of the corporation is VICTORY INDUSTRIES IMPORT EXPORT, INC., located at 17519 Southwest 140 Court, Miami, Florida 33177.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence.

**ARTICLE III - PURPOSE**
