ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is:

MARBET TRADING CO.

ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence on filing date.

ARTICLE III - PURPOSE
