FOR

The Undersigned, acting as incorporators of this business corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a Business Corporation under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be PRO-TECH CARPET CLEANING, INC.

ARTICLES II - TERM OF EXISTENCE

This corporation shall begin its corporation existence as of the 17th day of January, 1996, and shall exist perpetually.

ARTICLES III - GENERAL PURPOSE

The general purpose for which this corporation is organized shall be carpet cleaning and to do all things in connection therewith that are related services by a carpet cleaning company under the laws of the State of Florida. The business of the corporation shall be limited to the foregoing activities.

ARTICLE IV - CAPITAL STOCK

The corporation shall indemnify any incorporator, officer or director, of any former incorporator, officer or director, to the full extent permitted by law.


