
I am writing on behalf of the above-referenced taxpayers in response to the attached notice. While the taxpayers fully agree that they did not submit a corporate annual report, they have asked that you provide an opportunity to consider the circumstances surrounding their situation.

According to the taxpayer, the corporation did not receive a corporate annual report filing form nor did it receive a second notice informing them of their filing obligation. Unfortunately, since Mr. and Mrs. Hutchison are new to business ownership, they still rely heavily on these informative mailings to notify them of their various reporting requirements. As your records will indicate, they have promptly submitted all other state tax returns and business filings.

In light of the above circumstances, I feel that it would be unjust and unfair to require Mr. and Mrs. Hutchison to pay the reinstatement fee to avoid the dissolution of their corporation. At the direction of your office, they are submitting \$165, the full amount due for their annual report fee and corporate supplemental fee, along with a request for a waiver of the reinstatement fee.
