

**ARTICLES OF INCORPORATION  
OF

The following Articles of Incorporation are made pursuant to the "Florida Professional Service Corporation Act", Florida Statute 621, as amended.

**NAME AND PRINCIPAL OFFICE OF CORPORATION**

**AUTHORIZED SHARES**
