**ARTICLES OF INCORPORATION
OF
JTD LEASING CORP.**

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

**I.
Name**

The name of the Corporation is JTD Leasing Corp.

**II.
Term of Existence**

The date when corporate existence will commence is January 23, 1996 in accordance with the provisions of Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.

**III.
Principal Office**

Capital Stock**
