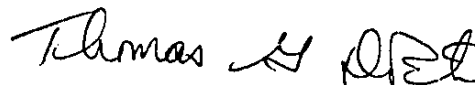

ARTICLE ONE

The name of the corporation is Durst Enterprises, Inc.

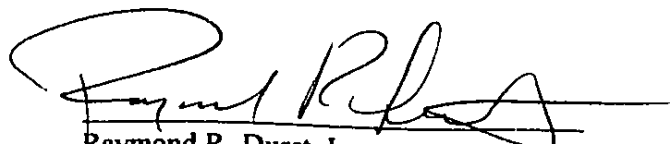
ARTICLE SIX

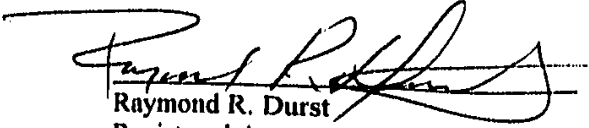
