The following provision of the Articles of Incorporation of FutureTrak International, Inc., a Florida corporation (the "Corporation"), filed with the Department of State on January 24, 1996, Charter Number P96000007235, be, and it hereby is amended pursuant to Section 607.1006 of the Business Corporation Act of the State of Florida as follows:

Article I of the Articles of Incorporation of this Corporation is amended to read in its entirety as follows:

**ARTICLE I
CORPORATE NAME**

The name of this Corporation shall be: **WORLDCAST INTERACTIVE, INC.**

The foregoing amendment was duly adopted by the Board of Directors and Majority Shareholders of the Corporation, dated as of November 9, 1999, pursuant to Sections 607.0704 and 607.0821 of the Florida Business Corporation Act. Therefore, the number of votes cast for the amendment to the Corporation's Articles of Incorporation was sufficient for approval.
