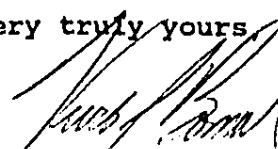

ARTICLES OF INCORPORATION
OF
LOGAN & CURRIN BUILDING ENTERPRISES, INC.

ARTICLE I - NAME

The name of this corporation is LOGAN & CURRIN ENTERPRISES, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

ARTICLE VII - INITIAL BOARD OF DIRECTORS

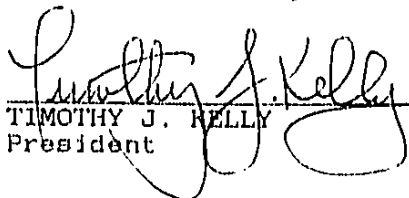

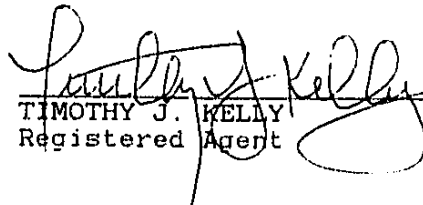

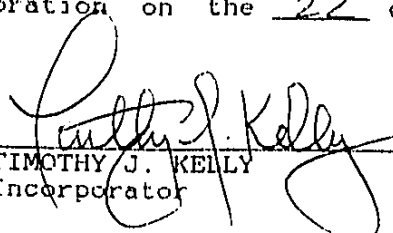
ARTICLE IX - INDEMNIFICATION

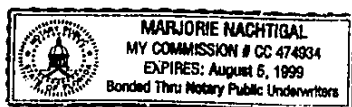
