ARTICLE I - NAME

The name of the corporation is HOUSING CONSTRUCTION SERVICES, INC. (hereinafter called the "Corporation")

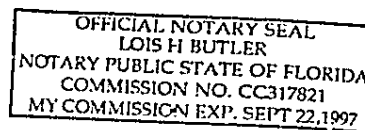
