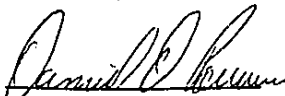
Pursuant to Section 607.0202, Florida Statutes, these articles of incorporation provide that:

1. The name of the corporation is **PRIORITY EXPRESS, INC.** (the "Corporation")
2. The principal office of the Corporation is 2367 S.W. 23rd Terr. Miami, FL 33145.
3. The aggregate number of shares which the Corporation is authorized to issue is one hundred (100) shares of Common Stock, par value \$1 per share.
4. The street address of the initial registered office of this Corporation is 2367 S.W. 23rd Terr., Miami, FL. 33145 and the name of the initial registered agent of this Corporation at that address is Yvonne Rodriguez.

The number of directors may be either increased or decreased from time to time as provided in the Bylaws of the Corporation, but shall never be less than one.

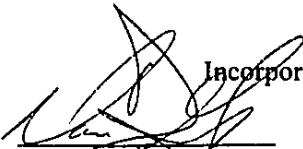

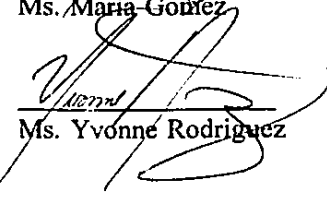
