The undersigned, the Incorporator of this corporation, a natural person competent to contract and an attorney-at-law, duly licensed to render services as such under the laws of the State of Florida, hereby presents these Articles of Incorporation for the formation of a corporation under the Professional Service Corporation Act (Chapter 621 Florida Statutes) and other laws of the State of Florida.

ARTICLE I

The name of this corporation is CHARLES COURSHON & ASSOCIATES, P.A.

ARTICLE II

This corporation shall have perpetual existence, and its corporate existence shall commence upon the filing of these Articles of Incorporation by the Department of State, State of Florida.

ARTICLE III

The general nature of the business to be transacted by this corporation is as follows:

1. To engage in every phase and aspect of the business of rendering the same professional services to the public that an attorney-at-law, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through its officers, employees and agents who are duly licensed under the laws of the State of Florida to practice law therein.

2. To invest the funds of this corporation in real estate, mortgages, stocks, bonds or any other type of investment and to own real and personal property, necessary for the rendering of professional services.

3. To do everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Incorporation or any amendment thereof, necessary or incidental to the protection and benefit of this

corporation, and in general, either alone or in association with other corporations, firms or individuals, to the accomplishment of the purposes or the attainment of the objects or the furtherance of such purposes or objects of this corporation.

The foregoing paragraphs shall be construed as enumerating both objects and purposes of this corporation; and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of this corporation, otherwise permitted by law.

#### ARTICLE IV

This corporation is authorized to issue one thousand (1,000) shares of common stock at One Dollar (\$1.00) par value.

#### ARTICLE V

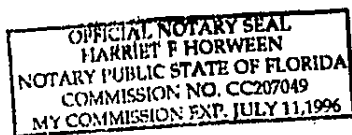
