## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF CAFE IGUANA OF FT. LAUDEDALE, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, CAFE IGUANA OF FT. LAUDEDALE, INC. (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation, as previously amended:
