ARTICLE I

The name of this corporation is EVANCO CORPORATION. The principal office and/or mailing address of this corporation is as follows: 361 Braden Avenue, Sarasota, Florida 34243.

ARTICLE II

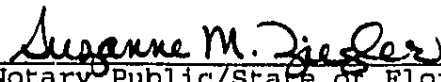

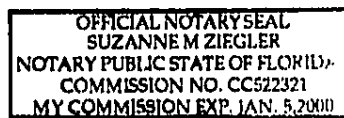

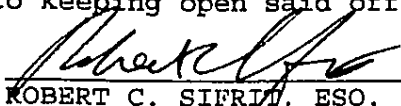
