ARTICLE I - NAME

The approval of the shareholders of this corporation to any plan of merger shall be required in every case, whether or not such approval is required by law.



ARTICLE XIII - CAPITAL AMOUNT

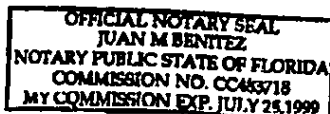
