ARTICLES OF CORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 607, Florida Statutes, adopt the following Articles of Corporation of such corporation:

ARTICLE I

Name

The name of the Corporation shall be:  
Florida International House , Inc.

The principal place of business of this corporation shall be:

ARTICLE II

Duration

The period of the duration of this corporation is perpetual unless dissolved according to the law.

ARTICLE III

Purpose

1. The Corporation exports and imports goods from/to the United States.
2. The Corporation may train and consult the party personnel who purchase the equipments, inside and outside the United States.
3. The Corporation may build facilities in and outside of the United States which might be needed to accommodate goods.
4. The Corporation may assimilate and manufacture goods.

ARTICLE IV

Membership

The Corporation shall have no members.

## ARTICLE V

### Directors and Regulation of Internal Affairs

- A. The exact number of Directors constituting the Board of Directors shall be two. The Chairman of the Board shall be the head of the Corporation. The names and addresses of the persons who are to serve is:

- B. The policies and affairs of the Corporation shall be set by the Board of Directors. The Board of Directors may elect or appoint persons to administer, operate and execute the purposes and the day-to-day affairs of the Corporation in any manner provided by in these articles and the By-Laws.
- C. The By-Laws and any amendments of the Articles of Corporation or the By-Laws, or their repeal shall be adopted by the majority members in a duly held meeting of the Board of Directors.

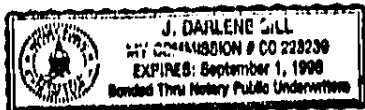
