Name

The name of the corporation is QUEST ENTERPRISE, INC.



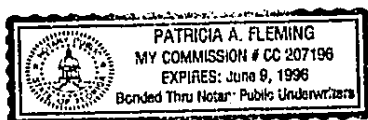


