ARTICLE I - NAME

The name of the corporation is ----- SPECIALIZED INVESTMENTS INC. and whose principal office location is 38513 U.S. HWY 19 N PALM HARBOR FL 34684

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:
VENDING MACHINE SALES and shall include the transaction of any and all lawful business for which corporations may be incorporated under State of Florida Statutes.

ARTICLE IV - CAPITAL STOCK
