The undersigned, acting as incorporators of the captioned corporation, under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I
Corporate Name**

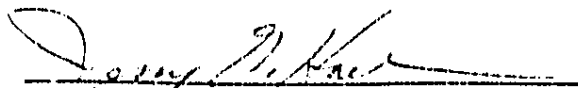
