**ARTICLES OF INCORPORATION
OF
VISION CORRECTION ASSOCIATES, P.A.**

FIRST: The undersigned, Charles M. Citrin, M.D., whose post office address is c/o 20/20 Laser Centers, Inc., 6701 Democracy Boulevard, Suite 200, Bethesda, Maryland 20817, does hereby form a professional corporation under the general laws of the State of Florida.

SECOND: The name of the professional corporation (which is hereafter referred to as the "Corporation") is Vision Correction Associates, P.A.

THIRD: The purposes for which the Corporation is formed are:

- (a) to render ophthalmology and optometry services;
- (b) to engage in any lawful business; and
- (c) to do anything permitted by Chapters 607 and 621 of the Florida Statutes, as amended from time to time.

FOURTH: The post office address of the principal office of the Corporation is 301 Yamato Road, Suite 1240, Boca Raton, Florida 33431.

FIFTH: The name and address of the resident agent of the Corporation are NRAI Services, Inc., 526 East Park Avenue, Tallahassee, Florida 32301.

SIXTH: The Corporation is authorized to issue one hundred (100) shares of common stock, with no par value.

SEVENTH: The initial number of directors of the Corporation shall be one (1), which number may be altered by and pursuant to the bylaws of the Corporation. The name of the initial director, who shall act until the first annual meeting or until his successor or successors have been chosen and qualified, is Charles M. Citrin, M.D., c/o 20/20 Laser Centers, Inc., 6701 Democracy Boulevard, Suite 200, Bethesda, Maryland 20817.


EIGHTH: The duration of the Corporation shall be perpetual.

NINTH: To the extent provided by Chapter 607.0850 of the Florida Statutes, as amended from time to time, or any successor provisions to that chapter, the Corporation may indemnify its officers, directors, employees, and agents, and any other person as determined by the Board of Directors.

TENTH: To the extent provided by Chapter 601.0831 of the Florida Statutes, as amended from time to time, or any successor provisions to that chapter, the Corporation's directors shall not be liable to the Corporation or its stockholders for any monetary damages.
