## ARTICLES OF INCORPORATION OF COOL ZONE, INC.



#### ARTICLE I. NAME

The name of this corporation shall be Cool Zone, Inc.

### 15 16 9 ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be on January 16, 1996. This corporation's duration shall be perpetual.

#### ARTICLE III. PURPOSE

This corporation is being organized for the purpose of air conditioning and heating sales and service business engaging in the transaction of any and all business activities permitted under the laws of Florida and the United States Of America.

#### ARTICLE IV. CAPITAL STOCK
