The undersigned, for the purpose of forming a Professional Service Corporation under the Florida General Corporation Act, and Florida Statute Chapter Section 621, does hereby adopt the following Articles of Incorporation:

- ARTICLE 1. Name. The name of the Corporation is: RHONDA H. NASSER P.A..
- ARTICLE 2. <u>Duration</u>. The duration of the Professional Service Corporation is perpetual.
- ARTICLE 3. <u>Purpose</u>. The general purposes for which the Professional Service Corporation is organized are the following:
