The undersigned, for the purpose of forming a corporation
for profit pursuant to Chapter 607, Florida Statutes, does hereby
adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is: ON LINE CAFE', INC.

ARTICLE II: DURATION

This corporation shall have perpetual existence commencing




