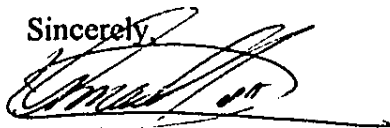

**ARTICLES OF INCORPORATION
OF**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a professional service corporation pursuant to the provisions of chapter 621 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is

GILBERT TOLEDO, D.M.D., PA

ARTICLE II NATURE OF BUSINESS

This corporation may engage or transact in the professional service of dentistry or any other lawful business activities permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation, with the exemptions established in the provisions of section 621.08 of Florida Statutes.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having \$1 par value per share.

The Board of Directors may from time to time designate such other address and place for the principal office of this Corporation as it may see fit.

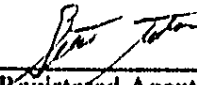
ARTICLE V - REGISTERED AGENT

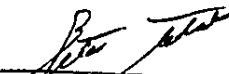

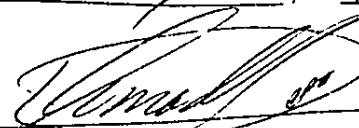
