On this 16th day of January, 1996, the undersigned incorporators hereby file with the Department of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

**ARTICLE I - NAME**

**ARTICLE II - TERMS OF EXISTENCE**

This corporation shall commence as of the date of the complete execution and acknowledgment of these ARTICLES.

**ARTICLE III - NATURE OF BUSINESS**

This corporation may engage in any activity or business permitted under the laws of the United States and of this State.

**ARTICLE IV - CAPITAL STRUCTURE**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time 10,000 shares of common stock, having per value of \$ .50 per share.
