ARTICLES OF INCORPORATION HANDCRAFT POTS OF AMERICA, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Busings/Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be: HANDCRAFT POTS OF AMERICA, INC.

ARTICLE II - DURATION

The Corporation shall have perpetual existence.

ARTICLE III

The general purpose of the business to be transacted by this Corporation are:

- A. Transacting any or all lawful business for which corporations may be incorporated under Florida Statutes.
- B. To engage in every phase and aspect of the distribution, marketing, representation, purchasing, selling, acquiring and disposing of merchandise at retail or wholesale to and from the United States.
- C. To invest the funds of this corporation in real estate, mortgages, stocks, bonds or any other type of investment, and to own real and personal property necessary for the accomplishment of the corporation's purposes.
- D. To do all and everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objectives or the furthermore of any hereof necessary and incidental to the protection and benefit of the corporation, and, in general, either alone or in association with other corporation, firms of individuals to carry on any lawful manner, pursuit necessary or incidental to the accomplishment of the purposes or objects of this corporation.
- E. The foregoing paragraphs shall be constructed as enumering both objects and purposes of this corporation and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of this corporation otherwise permitted by law.

ARTICLE IV - PRINCIPAL ADDRESS
