

ARTICIAS OF INCORPORATION OF



FOY E. DARK & ASSOCIATES, INC.

The undersigned, for the purpose of forming a corporation under the Florida Ceneral Corporation Act, hereby adopts the following Articles of Incorporation:

ARPICLE ONE: NAME: The name of the corporation shall be FOY E. DARK & ASSOCIATES, INC.

ARTICLE TWO: DURATION: The term of existence of the corporation is perpetual.
