**ARTICLES OF INCORPORATION
OF
DALE AND ROWLAND, P.A.**

KNOW ALL MEN BY THESE PRESENTS: That the undersigned incorporators do hereby incorporate a corporation under the provisions of Chapter 607, Florida Statutes, for the transaction of business with and under the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be and is **DALE AND ROWLAND, P.A.**

ARTICLE II

The duration of the corporation shall be and is perpetual, and the date and time of the commencement of the corporation's existence shall be and is the time these Articles of Incorporation are filed by the Department of State of the State of Florida.

ARTICLE III

The general purpose for which the corporation is initially organized are as follows:

- (a) To transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes; and
- (b) To engage in the practice of law. In addition with the above-mentioned purpose, the corporation may do any legal act that any other type of corporation may do under the laws of the State of Florida, except as is limited by Chapter 621, Florida Statutes (1993).

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1,000), all of which shall be of one and the same class and each of which shall be of a par value of One Dollar (\$1.00) per share.

ARTICLE V

The street address of the corporation's initial registered office is 1722 North Mills Avenue, Orlando, Florida 32803. The name of the corporation's initial registered agent is William M. Rowland, III. The address of the corporation's principal office is 1722 North Mills Avenue, Orlando, Florida 32803.

ARTICLE VI

There shall be two (2) Directors constituting the initial Board of Directors of the corporation. The names and addresses of the persons who are to serve as the members of the initial Board of Directors are:




