

ARTICLES OF INCORPORATION

ARTICLE ONE

The name of the corporation is S & S BRUNNER CO
The principal address of the corporation is: 910 A N.E. 2nd St.,

ARTICLE TWO

The period of its duration is perpetual.

The purpose for which the corporation is organized is the
transaction of any or all lawful business for which corporations may
