

The undersigned, acting as incorporator of Gaia Graphix, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. Name

The name of the corporation is:

Gaia Graphix, Inc.

ARTICLE II. Mailing Address

The mailing address of the corporation is:

Hallandale, Florida 33009

ARTICLE III. Commencement of Existence

The existence of the corporation will commence on the filing of these Articles of Incorporation.

ARTICLE IV. Purpose

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. Authorized Shares

The maximum number of share that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE VI. Initial Registered Office and Agent

The street address of the initial registered office of the corporation is 1501 Hallandale Beach Boulevard, Hallandale, Florida 33009, and the name of the corporation's initial registered agent at that address is Kevin Chan.

ARTICLE VI. Initial Board of Directors

The corporation shall have one director initially. The number of directors may be either increased or diminished from time to

time, as provided by the bylaws, but shall never be less than one. The name and street address of the initial director is:

#### ARTICLE VIII. Incorporator

#### ARTICLE IX. Bylaws

The power to adopt, alter, amend or repeal bylaws shall be vested in the board of directors and the shareholders, except that the board of directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that the bylaw is not subject to amendment or repeal by the directors.

#### ARTICLE X. Amendments

The corporation reserves the right to amend, alter, change, or repeal any provision in the Articles of Incorporation in the manner prescribed by law, and all rights conferred on shareholders are subject to this reservation.


