ARTICLES OF INCORPORATION

OF

LAWN MEDIC, INC., OF PINELLAS

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME.

The name of the corporation is LAWN MEDIC, INC., OF PINELLAS.

ARTICLE II. PRINCIPAL OFFICE AND REGISTERED AGENT.

The principal office of the Corporation is located at 3027 Key Harbor Drive, Safety Harbor, FL 34695. The registered agent at this address is Leonard M. Lentz.

ARTICLE III. DURATION.

The Corporation shall have perpetual existence.

ARTICLE IV. NATURE OF BUSINESS.

The general nature of the business to be transacted by this corporation is lawn care and maintenance and any other activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE V. POWERS.
