ARTICLES OF INCORPORATION

OF

Aerospace Design Fabrication and Welding, Inc.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: Aerospace Design Fabrication and Welding, Inc.
