### ARTICLE OF INCORPORATION

OF

# STONE INVESTMENTS CORPORATION, INC.

THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under Chapter 607 of the laws of the State of Florida, adopt the following Article of Incorporation for such corporation:

### ARTICLE I - NAME

The name of the corporation is STONE INVESTMENTS CORPORATION, INC.

#### ARTICLE II - DURATION

The period of its duration is perpetual.

## ARTICLE III - NATURE OF BUSINESS

The nature of the business and, the objects and purposes for which this corporation is organized are:
"To transact, promote and carry on all the business of Real Estate Investments, including but not limited to buying, selling and renting" "And any other lawful business activity for which corporations may be incorporated under Chapter 607 of the Florida Statues."

# ARTICLE IV - CAPITAL STOCK
