The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

Article I

NAME

The name of the corporation is DOMSEY FIBER SOUTH, INC.

This corporation shall exist perpetually.

CAPITAL STOCK

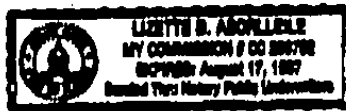
