KNOW ALL MEN BY THESE PRESENTS, THAT I, JAMES M. PHILLIPS JR., SECRETARY OF STATE
TALLAHASSEE, FLORIDA
do hereby certify that the foregoing is a true and correct copy of the Articles of Incorporation of the Statewide Building Inspectors, Inc., as filed in my office on this 24th day of January, 1996.

That the undersigned, natural person(s) of the age of at least eighteen (18) years, acting as Incorporator(s) of a Corporation under the FLORIDA Business Corporation Act, do hereby adopt the following Articles of Incorporation for such Corporation, to wit:

ARTICLE I

The name of this corporation is STATEWIDE BUILDING INSPECTORS, INC.

ARTICLE II

The period of duration of this Corporation shall be perpetual.

ARTICLE III

The purposes for which this Corporation is organized include all legal purposes for which a Corporation may be organized in FLORIDA.

ARTICLE IV

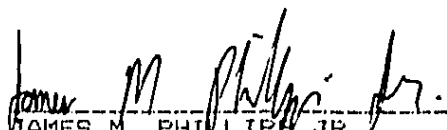

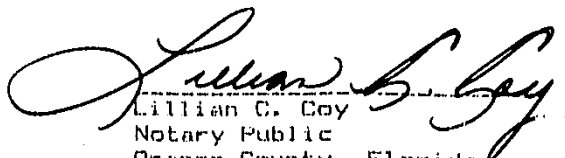
