ARTICLES OF INCORPORATION OF

SECRETARY OF STATE

The undersigned, acting as the incorporator of a corporation under the laws of the State of Florida, does make, subscribe, and acknowledge these Articles of Incorporation, pursuant to Soction 55 of the Florida General Corporation Act, and other applicable provisions of the Corporation Law of the State of Florida, and acts amendatory thereof and supplemental thereto.

FIRST: The name of this corporation is MUSCLE MEMORY MACHINES, INC.

SECOND: The period of duration of the corporation is perpetual.


