

## ARTICLES OF INCORPORATION OF LINEN & TEES EXPRESS, INC.



The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### **ARTICLE I**

The name of the corporation is LINEN & TEES EXPRESS, INC., whose principal place of business is 4970 SW 52nd Court, Davie, Florida 33314.

#### **ARTICLE II**

The period of duration of the corporation is perpetual.

#### **ARTICLE III**

The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of this State.

#### **ARTICLE IV**

The corporation shall have the authority to issue one thousand (1,000) shares, all of one class of Capital Stock, with a par value of \$1.00 per share.
