The undersigned Incorporator subscribing to these Articles of Incorporation, being competent to contract, hereby forms a Corporation under the Laws of the State of Florida.

ARTICLE I

The name of this Corporation shall be: FOLIAGE CONCEPTS CORPORATION, and its initial mailing address shall be: P. O. Box 100, Myakka City, Florida 34251. The initial address of the Corporation's principal office shall be: 3119 Manatee Avenue West, Bradenton, Florida 34205.

ARTICLE II

The purpose of this Corporation is to engage in any and all business not prohibited by the Laws of the State of Florida.

This Corporation shall have all powers given corporations under the Laws of the State of Florida.
