ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, desiring to form a corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation as the charter of the corporation hereby organized.

ARTICLE I

NAME: The name of this corporation is ROB ROD, Inc.

ARTICLE II

DURATION: This corporation shall have perpetual existence, commencing upon the date of filing of these Articles of Incorporation with the Department of State, State of Florida.

ARTICLE III

PURPOSE: This corporation is organized for the purpose of engaging in real property rental. Also to engage in all lawful businesses as permitted to a corporation organized under the Florida general corporation law, as in effect from time to time.

ARTICLE IV

CAPITAL STOCK: This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock, payable in lawful money of the United State of America or in other property, tangible or intangible, or in labor or services actually performed for the corporation at a just valuation to be fixed by the board of directors or shareholders of this corporation. The capital stock of this corporation may at any time be increased or decreased as provided by the laws of Florida.

ARTICLE V

INITIAL REGISTERED OFFICE AND AGENT: The street address of the initial registered office of this corporation is 1501 Mulberry Drive, Tampa, Florida, 33604, and the name of the initial registered agent of this corporation at that address is Robert E. Rodriguez. The principal address and the registered office address shall be the same.

ARTICLE VI

INITIAL BOARD OF DIRECTORS: This corporation shall have (1) director initially. The number of directors may be either increased or decreased from time to time by the bylaws, but shall never be less than one. The names and addresses of the initial directors of this corporation are:

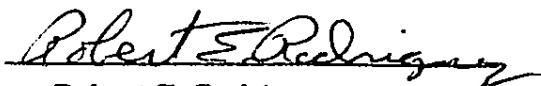

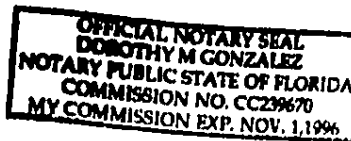
