
ARTICLE VII - INCORPORATION

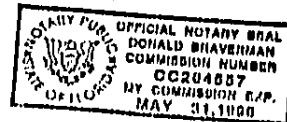
