articles of incorporation

SECRETARY OF STOR WEST SOUTH FLORIDA MARINE CORPORATION

We, the undersigned, being natural persons of the age of twenty-one (21) years or more, and subscribers to the shares of the corporation to be organized pursuant hereto, for the purpose of forming a for profit corporation under Title XXXVI Chapter 607, do hereby adopt the following Articles of Incorporation.

ARTICLE ONE

WESTS The name of the corporation is South Florida Marine Corporation.

ARTICLE TWO

The number of directors of the corporation to constitute the board of directors shall be two (2).

The duration of the corporation is perpetual.

- (e) To apply for, purchase or in any manner to acquire; to hold, own, use and operate, to sell or in any manner dispose of., to grant or license other rights in respect of, and in any manner deal with, any and all rights, interests, inventions, improvements and processes used in connection with or secured under letters patent or copyrights of the United States or other countries or otherwise, and to work, operate or develop the same.
- (f) To purchase, lease or otherwise acquire and to hold, own, sell or dispose of real and personal property of all kinds and in particular lands, buildings, business concerns, shares of stock, mortgages, bonds, debentures and other securities, merchandise, book debts and claims, trademarks, trade names, and any interest in real or personal property.
- (9) To borrow money for its corporate purposes, and to make, accept, endorse, execute and issue promissory notes, bills of exchange, bonds, debentures or other obligations from time to time, for the purchase of property, or for any purpose in or about the business of the corporation, and if deemed proper, to secure the payment of any such obligations by mortgage, pledge, deed of trust or otherwise.
