ARTICLE I - NAME

The name of this corporation is LASTINGER CORPORATION.

ARTICLE II - DURATION

The corporation shall exist perpetually.

ARTICLE III - PURPOSE

A. To engage in every phase and every aspect of the business of rendering the same professional services to the public that an automobile damage appraiser, duly licensed under the laws of the State of Florida, is authorized to render but such professional services shall be rendered only through individuals authorized by the laws of the State of Florida to render such professional services. The corporation shall also be authorized to engage in any other business enterprise which can lawfully be operated within the State of Florida.

B. To invest the funds of the corporation in real estate, mortgages, stocks, bonds or any other type of investment, and to own real and personal property necessary for performing the tasks described in paragraph A.

C. To do everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects for the furtherance of any of the purposes enumerated in this Certificate of Incorporation or any amendment thereof, necessary or incidental to the protection and benefit of the corporation.

The foregoing paragraphs shall be construed as enumerating both objects, purposes and powers of the corporation; and it is hereby expressly provided that the foregoing enumerations of specific powers shall not be held to limit or restrict in any manner the powers of the corporation otherwise permitted by law.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of ONE (\$1.00) Dollar par value common stock.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 5458 Hoffner Avenue, Suite 304, Orlando, FL 32812 and the name of the initial registered agent of this corporation at that address is DAVID M. LASTINGER. The address of the principal office of the corporation is 5458 Hoffner Avenue, Suite 304, Orlando, FL 32812.

ARTICLE VI - BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be increased or decreased from time to time by the by-laws, but shall never be less than one (1) nor more than the number of registered stockholders.
